## Tri County Housing to Announce Winner of "Housing Advocate of the Year Award" at Annual Golf Outing

The eighth annual golf outing fundraiser of Tri County Housing (formerly Tri County Housing Development Corporation) will take place on **Tuesday, Aug. 15** at Sportsman's Golf Course in Susquehanna Twp., and will start with the announcement of the winner of the "Housing Advocate of the Year" Award.

This year's recipient is Robin Wiessmann, Executive Director and CEO of the Pennsylvania Housing Finance Agency (PHFA), and former state Treasurer and Secretary of Banking, who will appear to accept the honor.

Tri County Executive Director Gary Lenker said Wiessmann has exhibited extraordinary leadership and support for affordable housing for low- to moderate-income families, and compiled a lifetime of public service as a cabinet official and policy leader.

Tri County operates as a certified Community Housing Development Organization (CDHO) to rehabilitate abandoned and blighted properties in the City of Harrisburg and throughout Dauphin, Cumberland and Perry counties. Recent successful projects include affordable homes for sale in the South Allison Hill neighborhood of Harrisburg, on both Hummel Street and Swatara Street, along with properties on Frank S. Brown Boulevard in Steelton Borough and East South Street in Carlisle. In June of 2022, Tri County moved its office to 201 North Front Street, first floor, in downtown Harrisburg, in the PHFA headquarters, and has been offering Home Buyer counseling to first-time buyers.
